Incorporation	LLP Deed / Partnership Deed	Total initial capital contribution by all partners
	Company MOA & AOA	Authorized capital
	Deed of Trust	Monetary and non-monetary value of assets (including cash, property, etc.) settled by the Settlor in the Trust
Business & Commercial Agreements	JV Agreement	Authorized capital
	Website Development Agreement	Total consideration for the services, including website maintenance fees, applicable taxes, and all other related charges (paid or payable)
	Sale of Goods	Total consideration for the goods, including applicable taxes, shipping charges and all other related charges (paid or payable)
	Sale of Services	Total consideration for the services, including applicable taxes and all other related charges (paid or payable) (NOTE: if the service is time based, then total consideration for the services for the period covered by the plan, i.e., 1 year)
	Employment Agreement	Total compensation, including salary, incentives, allowances, etc., for the period covered by the plan, i.e., 1 year
	Agreement for Equipment Rental	Total consideration (paid or payable) for the period covered by the plan, i.e., 1 year. If period is less than 1 year, then total consideration for the duration of the agreement. The consideration shall include the rental charges, security deposit, applicable taxes and all other related charges
