PRESOLVDIRECT FEE SCHEDULE

About Presolv360

What is 'PresolvDirect'?

'PresolvDirect' is a direct dispute resolution service, wherein parties can refer an existing dispute to Presolv360's revolutionary dispute resolution mechanism, for a quick, economical and effective resolution. 'PresolvDirect' blends human expertise, innovation and technology to provide quality end-to-end collaborative dispute resolution services.

The fee structure is as follows:

1. Consultation Fees:

The Disputing Party(ies) may choose to opt for an optional consultation to understand how the PresolvDirect Dispute Resolution Mechanism could assist them in coming to an effective resolution. The Consultation Fees shall be payable before booking an appointment with Presolv360, which shall be non-refundable.

Fee: Rs. 1,000/-

2. Registration Fees:

The Registration Fees, i.e., a one-time fee, shall be payable at the time of referring the dispute to Presolv360, which shall be non-refundable.

Fee: Rs. 750/-

3. Professional Fees:

Professional Fees shall be payable before commencing the PresolvDirect Dispute Resolution Mechanism, for 2 sessions together, after which, it shall be payable for every additional session, at least 3 days before the date of the session, which shall be non-refundable.

The Professional Fees shall be as follows:

Type of Dispute	Per Session	Per Day
Commercial	Rs. 9,000	Rs. 16,000
Non-commercial	Rs. 7,500	Rs. 13,000

Note: One session is of 3 hours, or part thereof, and may be conducted singly with a particular party to the dispute, and/or jointly with two or more parties to the dispute. One day consists of 2 sessions, each of 3 hours, or part thereof, and may be conducted singly with a particular party to the dispute, and/or jointly with two or more parties to the dispute.

PresolvDirect Fee Schedule

The **Rental Charges** shall be payable, based on choice of location, before commencing the PresolvDirect Dispute Resolution Mechanism, for 2 sessions together, after which, it shall be payable for every additional session, atleast 3 days before the date of the session.

The **Out-of-Pocket Expenses** (OPE) shall be payable, based on actuals, after the session, within 3 days from the date of submission of OPE Expense Invoice by Presolv360.

Note:

1. These rates are excluding taxes.
2. These rates are for a maximum of 3 disputing parties, with disputed amount not exceeding Rs. 30,00,000.
